THE EXECUTIVE DIRECTOR. A REPORT OF THE RESULTS IS SHARED WITH THE ENTIRE BOARD WHO THEN DECIDES ON AREAS OF STRENGTHS AND IMPROVEMENTS. A FINAL DOCUMENT OF THE BOARD'S DECISIONS ARE DEVELOPED ALONG WITH AN ACTION AND ANY SALARY ADJUSTMENTS THEY DEEM APPROPRIATE. WHEN THE BOARD CONSIDERS AN INCREASE IN COMPENSATION THEY TAKE INTO CONSIDERATION THE PERFORMANCE REVIEW AS WELL AS CURRENT DATA THAT IS AVAILABLE BOTH NATIONALLY AND LOCALLY FOR EXECUTIVE DIRECTOR COMPENSATION IN THE NON-PROFIT SECTOR.
