UAHT ENGAGED AND MANAGED THE WORK OF ONE SUBCONTRACTED ORGANIZATION THAT HELPED UAHT BUILD CAPACITY AND AWARENESS AROUND THE ISSUE OF HUMAN TRAFFICKING THROUGHOUT THE GREATER HOUSTON AREA. THE OUTREACH PROGRAM TARGETED MINORITY POPULATIONS, WHICH FOCUSED ON RAISING AWARENESS TO INCREASE IDENTIFICATION OF TRAFFICKING VICTIMS WITHIN THE LATINO POPULATION. IN ADDITION, THIS PROJECT ALSO FOCUSED ON TRAINING AND PREPARING WORKERS TO IDENTIFY AND AVOID POTENTIAL LABOR TRAFFICKING SITUATIONS THEMSELVES AND HOW TO IDENTIFY AND REPORT TRAFFICKING WITHIN THEIR COMMUNITIES.

UAHT BELIEVES THAT AN AWARE AND EDUCATED PUBLIC IS THE FIRST STEP TO ELIMINATING HUMAN TRAFFICKING UAHT'S PUBLIC AWARENESS CAMPAIGNS ACHIEVE THIS OBJECTIVE THROUGH THE USE OF A VARIETY OF COMMUNITY OUTREACH PROJECTS THAT EDUCATE THE PUBLIC ABOUT HUMAN TRAFFICKING AND ITS PREVALENCE ON A GLOBAL, NATIONAL AND LOCAL SCALE. UAHT ALSO AIMS TO EMPOWER THE COMMUNITY TO TAKE ACTION AND EDUCATE THEM ABOUT THE ROLE THEY PLAY IN COMBATTING THIS CRIME. UAHT'S PUBLIC AWARENESS CAMPAIGNS INCLUDE AN ANNUAL HUMAN TRAFFICKING AWARENESS MONTH, THE LOOK BENEATH THE SURFACE EDUCATIONAL ART EXHIBIT AND MEDIA CAMPAIGNS (SUCH AS HIGHWAY BILLBOARDS, MALL SIGNAGE AND PSAS). UAHT ALSO EDUCATES THE COMMUNITY THROUGH COMMUNITY HUMAN TRAFFICKING PRESENTATIONS AS WELL AS A VOLUNTEER PROGRAM.

UAHT IDENTIFIES KEY FRONT-LINE PROFESSIONALS, SUCH AS LAW ENFORCEMENT, HEALTH CARE PROVIDERS, SOCIAL WORKERS, EDUCATORS, EMS, 911 CALL-TAKERS AND OTHERS WHO ARE IN THE BEST POSITION TO COME INTO CONTACT WITH A VICTIM OF HUMAN TRAFFICKING.
